The Truth and Lending act requires that all customers be told the full details of any finance charges. This institution will impose a finance charge on any student choosing to pay tuition by weekly or monthly installments. The finance charge for both the 200-hour Canine Massage distance study program and the onsite 200-hour Small Animal/Canine Massage program is as follows: The \$1,600 tuition charge for the 200-hour Canine Massage distance study program will become \$1,700 for a six month payment plan. The \$2,000 tuition charged for the onsite 200 hour Small Animal/Canine Massage program will become \$2,100 for a six month payment plan. If a payment option is chosen for any of the above programs, a payment schedule will be discussed and agreed upon with the schools enrollment advisor.

Make-up work in a certificate program is the responsibility of each individual student. Missed classes may be made-up in a future course or via Skype Instruction.

The Fair Credit Billing Act requires us to make prompt correction of a billing mistake. Please notify the school if you feel that you have been billed incorrectly. We will take immediate action to correct any mistakes.

NOTICE CONCERNING TRANSFERABILITY OF CREDITS AND CREDENTIALS EARNED AT OUR INSTITUTION

The transferability of credits you earn at the Ojai School of Canine Massage is at the complete discretion of an institution to which you may seek to transfer. Acceptance of the certificate you earn in the Small Animal/Canine massage program is also at the complete discretion of the institution to which you may seek to transfer. If the certificate that you earn at this institution is not accepted at the institution to which you seek to transfer, you may be required to repeat some or all of your coursework at that institution. For this reason, you should make certain that your attendance at this institution will meet your educational goals. This may include contacting an institution to which you may seek to transfer, after attending the Ojai School of Canine Massage, to determine if your certificate will transfer.

D. REFUND PROVISIONS

CANCELLATION OF AGREEMENT AND STUDENTS RIGHT TO CANCEL

You have the right to cancel this agreement for a course of instruction and receive a pro rata refund for the course material which you have not yet received through the onsite or online program. There will be no refund for online course material which is previously sent to you, by your request, after you have enrolled. Students cancelling after the start date of the onsite program will be charged for only the course work taken. The \$300 registration fee is nonrefundable.

In addition, a student may withdraw from an onsite course, after instruction has started, and receive a pro rata refund for the unused portion of the tuition and other refundable charges if the student has completed 60% or less of the instruction. There is no refund when more than 60% of a course is taken.

Cancellation shall occur when you give written notice of cancellation at the following address:

You can do this by regular mail or email. The written notice of cancellation, if sent by mail, is effective when deposited in the mail properly addressed with postage prepaid.

The written notice of cancellation need not take any particular form and, however expressed, it is effective if it shows that you no longer wish to be bound by this Agreement. The Ojai School of Canine Massage can provide you with a cancellation form or you can use any written notice you wish.

If the School has given you any equipment, including books or other materials, you shall return it to the School within 30 days following the date of your notice of cancellation. If you fail to return this equipment, including books, or other materials in good condition within the 30-day period, the School may deduct its documented cost for the equipment from any refund that may be due you. Once you pay for the equipment, it is yours to keep without further obligation.

If you cancel this agreement, the School will refund any money due, less any deduction for equipment not timely returned in good condition, within 30 days after your notice of cancellation is received.

If the School cancels or discontinues a course or educational program, the School will make a full refund of all charges for coursework not received by the student. Refunds will be paid within 30 days of cancellation or withdrawal. If you obtain equipment (as specified in the agreement as a separate charge) and return it in good condition within 30 days following the date of your withdrawal, the school shall refund the charge for the equipment paid by you. If you fail to return the equipment in good condition, allowing for reasonable wear and tear (within this 30-day period) the school may offset against the refund the documented cost to the school of that equipment. You shall be liable for the amount, if any, by which the documented cost for equipment exceeds the prorated refund amount. The documented cost of the equipment may be less than the amount charged, and the amount the school has charged in the contract. In any event, you will never be charged for more than the equipment charges stated in the contract. IF THE AMOUNT THAT YOU HAVE PAID IS MORE THAN THE AMOUNT THAT YOU OWE FOR THE TIME YOU ATTENDED, THEN A REFUND WILL BE MADE WITHIN 30 DAYS OF WITHDRAWAL. IF THE AMOUNT THAT YOU OWE IS MORE THAN THE AMOUNT THAT YOU HAVE ALREADY PAID, THEN YOU WILL HAVE TO MAKE ARRANGEMENTS TO PAY IT.
